This offer of appointment is subject to the following terms and conditions:

- 1) The post is temporary and he/she will be appointed on officiating basis only.
- 2) The appointment is tenure based as per terms and conditions of the Residency Scheme and governed by the Temporary Service Rule, 1965.
- 3) **His/her present tenure of appointment will be for one year which is extendable every year for a maximum period of 3 years subject to satisfactory performance and good work and conduct report from the Head of Unit concerned. The period of service rendered by him/her as Senior Resident prior to this appointment on adhoc/regular basis in any institution anywhere in India, if any, shall be counted while reckoning the tenure as Senior Resident. All rights of extension are reserved with the Director (GNEC).**
- 4) The appointment can be terminated at any time by giving one month notice by either side viz the appointee or the appointing authority without assigning any reason. The appointing authority, however reserves the right of terminating the services forthwith on or before the expiry of the stipulated period by making payment of a sum equivalent to the pay and allowances for the notice period or the un-expired portion thereof.
- 5) **Private practice of any kind whatsoever is strictly prohibited.**
- 6) The appointee is required to state whether he/she is under any service or obligation to serve any Centre/State Government Department or Public Sector Authority. In case of yes, the discharge certificate from the previous employer concerned is required.
- 7) Other conditions of service will be governed by the relevant rules and orders in force from time to time.

The appointment is further subject to:

- a) Medical fitness certificate from the appropriate authority concerned.
- b) Verification of the Character and Antecedent report from Commissioner of Police/Distt. Magistrate of concerned city/state where candidate has been residing or resided for more than one year at a time during the last five years.
- c) Production of a valid caste certificate, if any, relating to the claim of belonging to SC/ST/OBC (Delhi)/EWS/PwD category and its verification thereof by concerned authorities.
- d) Production and verification of Registration Certificate from Delhi Medical Council.
- e) Production of Proof of Age, educational qualifications and other certificate (in original) and caste certificate of SC/ST/OBC (Delhi)/EWS/PwD category (for reserve category).
- f) An undertaking to the effect that he/she has not done the Senior Residency for a period of three years, prior to appointment.

**In case the offer of appointment is acceptable on the terms and conditions mentioned above, he/she should submit his/her acceptance of the offer to the undersigned immediately or within 07 working days from the date of issue of this offer and report to the Administration Branch, Guru Nanak Eye Centre along with the original documents and one set of attested photocopy and 04 passport size recent photos.**

If no reply is received within the prescribed time limits, it will be presumed that he/she is not interested in the offer and this offer will be treated as cancelled automatically without any further correspondence.
